

HEAT UP YOUR SALES WITH THE CADILLAC ACCESSORIES

DEALER BONUS DAZE



All 2013 Mark of Excellence (MOE) enrolled dealers are automatically enrolled to earn one of two Cadillac Accessories **Dealer Bonus Daze** amounts for eligible deliveries made during the program period May 1, 2013 through July 1, 2013.

HERE'S HOW IT WORKS

To qualify for the Cadillac Accessories **Dealer Bonus Daze**, your dealership must meet or exceed one of the two Bonus Levels outlined to the right.

DEALER BONUS LEVELS

LEVEL 1 BONUS: \$20 per eligible delivery Meet or exceed one of the following:

- Your Cadillac Accessories sales May and June combined objective* OR
- Per New Unit Retail (PNUR) May and June combined objective**

LEVEL 2 BONUS: \$25 per eligible delivery Meet or exceed <u>both</u> of the following:

- Cadillac Accessories sales May and June combined objective* AND
- Per New Unit Retail (PNUR) May and June combined objective**

ELIGIBLE DELIVERIES: Eligible delivery types are based on the same criteria as the 2013 SFE program. See Cadillac Accessories Dealer Bonus Daze program website (www.gmexcellence.com) for additional information.

BUY/SELL DEALERS: In the event that a dealer completes a buy/sell during May and/or June 2013 and qualifies for the Cadillac Accessories Dealer Bonus Daze, payouts will be directed to the purchasing dealer. Actuals for both Accessories Sales and \$PNUR do not carry over to purchasing dealer.

DEALER PAY-OUT: Dealers who earn the Cadillac Accessories Dealer Bonus Daze will be paid via their open account the last week of July, 2013.

All Accessory Bonuses paid and eligible VINs reported are subject to audit and charge-back for non-compliance with any program rules. Dealers that forfeit May and June eligible units due to "return-to-stock" activity may be impacted for 2013 Cadillac Accessories Dealer Bonus Daze. Accessories sales are subject to audit after 2013 bonus payments are made.
